## Investment Vehicles

Investment vehicles can be used for different goals. However, your investment plan or solutions inside each are the same. Some investment vehicles include:

- TFSA
- RRSP
- RESP
- Non-registered





# 2. Tax-Free Savings Account (TFSA)

- A TFSA allows investment income and capital gains to grow tax-free
- This tax-free growth means your money grows more quickly in a TFSA than in a taxable account
- No tax is paid on any funds that are withdrawn from the account, please note you lose the contribution room for that year
- TFSA contributions are limited per individual, make sure to check your contribution room with CRA before investing

#### **3.** Registered Retirement Savings Plan (RRSP)

- An RRSP is a personal savings plan that allows you to save for long-term goals, specifically your retirement
- There are special circumstances when you can withdraw from your RRSP early (i.e. Home Buyers' Plan)
- It allows earnings to compound on a tax-deferred basis and can reduce your taxable income at the end of the year
- Taxes are paid on the funds withdrawn from the account
- RRSP contributions are limited per individual, make sure to check your contribution room with CRA before investing

### Registered Education Savings Plan (RESP)

- An RESP is a tax-deferred account and an effective way to help plan for a child's future
- Government grants may be available for children under the age of 17
- Taking advantage of this account can give your child up to a max of \$7,200 from the government towards their post-secondary education
