f. 2022/23 Budget

PARSONS asks what a discretionary fund under the President's portfolio is. MCGOWAN explains this budget line is to provide the President with funding to use for particular situations, PECOSKIE-SCHWEIR has written a policy with more specifics which will be sent to the directors. PARSONS asks if the budget is posted on the website? MCGOWAN says yes. PARSONS suggests adding an explanation to the budget line to ensure students are not confused as to what it covers. MCGOWAN explains that there will be a line by line document to be posted with descriptions of each budget line. PARSONS asks if the payroll and benefits covers all NUSU Staff and Executives. TAYLOR says yes, just the NUSU staff, it does not include the bar and restaurant staff. MCGOWAN explains that this budget does not reflect our current salaries, it allows for future employees to be hired. PARSONS asks about the automobile budget line, why is it so high? TAYLOR explains NUSU is purchasing a new

company vehicle. PARSONS asks if nothing on the budget is allocated to the bar? TAYLOR explains that the Music and Entertainment budget line would be used for external entertainment such as the time we brought in the video games or if we wanted to show a movie. PARSONS are the budgets higher than planned? TAYLOR explains that they looked at the proposed fees NUSU would receive and the proposed budget, more money was allocated to each budget line to ensure that we are on track to be in a deficit. MCGOWAN explains that now that the building is open, more events will take place which will require a larger budget. NUSU has also spoken to Nipissing about the DJ and Buses for the night club, night owls, etc. MCGOWAN explains that NUSU will coordinate with the campus library to ensure that students have access to on campus support as often as possible.
